SUMMARY OF TOTAL COST OF FEES & LEVIES FOR 2020 AT ST. ANTHONY'S SCHOOL

This table has been calculated for your convenience as a quick reference to schooling costs for your child. The figures below include Tuition Fees and all levies.

The amount listed for 2 students is a **total for all students**, not per student.

Diocesan School Fees

Federal and State Governments acknowledge the right of parents to choose the school which best suits their children's needs for educational, religious, cultural or other reasons.

However, in comparison with funds spent on students in government schools, government funds committed to non-government schools remain limited. Your contribution through school fees is essential to the continued operation of your Catholic School.

Your school fees consist of a Tuition Fee, School Building Levy and Technology Levy set by DCEO and other School-Based Levies. School-Based Levies are approved by the School Board – to be no greater than the 25% of the non-discounted tuition fees per student.

Tuition Fees are subject to discounts per number of children attending a Catholic Primary or Catholic High School in the Rockhampton Diocese. ***Weekly amounts are calculated on 40 school weeks per year.**

Building Levy

The School Building Levy funds the building of classrooms and new schools.

The annual charge is \$372 per family.

Technology Levy

The Technology Levy represents a contribution towards the maintenance and replacement of technology hardware and software.

The annual charge per child is \$100 with a maximum of \$200.00 per family.

School- Based Levies

The School-Based Levies are charges for curriculum resources and library books. Costs are tabled below;

St Anthony's Fundraising Levy

The Fundraising levy operates on a per family basis of \$120 per year. It represents a contribution to school projects and replaces the requirement for major fundraising except for the biennial school fete.

Catholic School Parents Queensland Levy

A levy of \$6.45 (approx. cost) per child will be included on the Term 1 fee account, to pay for affiliation fees with the Catholic School Parents Queensland. This is different to the St. Anthony's Fundraising levy. This body advocates for Catholic Education at State and Federal levels of Government to obtain more equitable funding for our schools.
